"Before I formally make the recommendations for the Head Varsity Boys Basketball Coach and Assistant Varsity/Head JV Boys Basketball Coach, I want to recognize the selection team that conducted the interviews. Those individuals on the selection team are : Mr. Jerry Miller, Mr. Drew Carlin, Mrs. BJ Awald, Mr. Jim Ash, Ms. Linda Bajgrowicz, Mr. Terry Minix, Mr. Scott Green and myself. I am recommending Mr. Larry Sennert to be employed as the Head Varsity Boys Basketball Coach.

Larry began his coaching career in 1985 in the Knox Community School Corporation and between 2001-2010 was the JV Boys' Basketball Coach. Larry has coached over 350 games and is a licensed basketball official for 26 years. The selection team believes that Larry brings coaching experience to our athletic department, knowledge of the game of basketball and is eager to make an impact with our student/athletes as well as our community.

I am recommending Mr. Daniel Henigsmith to be employed as the Assistant Varsity/Head JV Boys Basketball Coach.

Das has coached basketball at the junior high level for 3 years, including last year as a girls junior high basketball coach at Oregon-Davis. Dan has worked with our varsity boys basketball program and specifically has led workouts for the past several months. The selection team believes that Dan has demonstrated dedication to the student/athletes at Oregon-Davis, especially our varsity boys basketball program the past several months. Das has built a very positive and strong rapport with many of our male athletes. Dan also has a bright future ahead of him as a coach as he gains experience working with Coach Larry Sennert.

Before asking for a vote Mr. Lawrence also thanked the committee for the time spent in the interviewing process.
