Mr. Bennett also stated a chart was added showing when a student, faculty or staff member could return to school after being sent home. Mrs. Ferch then called for a vote

Motion to approve was made by Mr. Hinds, second by Mr. Hayes Motion passed 4-1 with Ms. Ecker casting the lone dissenting vote.

6. Reports

6.01 Superintendent's Report – Mr. Bennett asked for everyone to keep Kayla Skaggs and her family in their thoughts and prayer as she lost her father this past weekend.

Mr. Bennett stated we had a great start in person at the elementary and he commended the staff for all the hard work they have put in to make that day go so well. Virtual was not as smooth with a major storm the night before that interfered with power and internet connections and new programs.

Athletics will start this week. Spectators will be spaced out in the gym and traffic will be targeted to limit the spaces used by the public.

The corporation is starting to see in the elementary students switching from virtual back to inperson learning, some of that has been happening in the high school as well.

Enrollment numbers today were at 501.

Bottle refill stations should be coming in this week or next.

An insurance claim has been started as we learn of items that were affected by the power outage due to the storm.

Mr. Bennett said Ms. Quinn is doing an outstanding job at the Elementary and Mrs. Awald at the Jr/Sr High School.

He did recognize Bellman Oil for their water donation and Mr. Lawrence for his labor on the soccer field.

6.02 Principal's Reports - Mrs. Awald explained how they functioned on the first day of school to orient the students to new procedures. Training on Covid, Schoology also took place as well as protocols outlined in the student handbook also took place that day. She said the kids have adapted well to assigned seating, mask wearing, carrying backpacks and using water bottles. She

was very proud of well they have done. The High School only has about 15% virtual (7-12th grade) now.

Mrs. Awald has also been mentoring the new counselor and will be meeting with her once a week after school to help with the transition.

7. Board Comments

Ms. Ecker noted that we did not have an attorney present again and feels it is time to look for another.

Mr. Hinds asked about the process after bond sale. Mr. Bennett replied he has started meeting with them to prioritize projects and they are working on more specific choices and costs involved. The bond money will be invested until the project starts.

Mr. Hinds asked if Baker Tilly would come to a board meeting to discuss the financial situation of the corporation. Mr. Bennett said he would like to schedule a work session for that along with the budget information.
