6.01 Superintendent Reports – Mr. Bennett reported that the SRO car is back from getting wrapped and it looks very nice. This was all paid for, the car and the wrap through donations. Almost a full staff is back, many students returned today so hopefully we can get a good stretch in before Thanksgiving. He wanted to extend his appreciation to staff, paras, teacher, cafeteria and office staff at the elementary that helped while virtual. There were between 30- and 40 students that came for homework help during that time and it was a great service for those students. In the future much will depend on staffing but we could see the Jr./Sr High School doing something different than the Elementary. We did get approval that student lunches will be free through the end of the school year.

6.02 Principal's Reports – Ms. Quinn- fire prevention week was before we went virtual. Eight students were picked up and brought to school on a fire truck. Some high school students came and talked to the students about fire prevention. Ms. Quinn also expressed her appreciation for all the staff that jumped into help during the virtual period. A Halloween parade will not be held this year due to Covid. The majority of the staff voted that the kids wear their costumes to school that Friday and do some fun academic activities on that day. Packaged snacks will be served in their classrooms. Ms. Quinn answered a question about ALICE training. Mr. Kohles did not use the nerf gun but was able to go into each classroom and talk to them.

Mrs. Awald – Mrs. Awald thanked Ms. Quinn for her supervision at the elementary during the quarantine. Two Jr/Sr high students used this option and there were a couple of teachers and a para from the Jr/Sr High that went over to help. Veteran's Day will be different this year. Veterans will be honored but there will not be anyone coming into the school for a program. Staff and students are working on a video to honor the veterans with the background music being played by the band that will be posted on social media.
