The Board of School Trustees of the Oregon-Davis School Corporation met in Regular Session on Monday evening, at 6:00 PM in the Humanities Room of the Jr/Sr High School.

1. Meeting Opening

- Mr. Hinds read a statement before opening up public comment. The statement follows:

"Before we begin this evening, I want to just touch on our current public comment policy and common practice. In reviewing our policy, I noticed that we have often been much more lenient on what the public comments are in regards to. Current policy states we will accept comments only on agenda items. As many of you know this board has always been willing to allow comment on items not on our agenda and allowing folks plenty of time to get their message across.

On this specifically we have pride in ourselves for allowing flexibility so that we can hear from the public, both the good and the bad. We think this is important in moving our school corporation in a positive direction.

With that being said I want to remind those in attendance. This is a private meeting, that is held in public, so that you all can be of witness to our actions. We gladly invite your participation and comment, but where our policy must draw the line is on individual personnel matters. We simply cannot allow for discussions of individual employee's actions. These personnel issues are prohibited from being discussed in an open meeting by board policy and state law. With that being said, we would like to continue to see parents in our meeting room. Your concern and commitment to the students of this school is admired by this board, and we are excited to see you here.

This board will be reviewing our public comment policy in the coming months. It is my personal hope that we can make modifications as to not limit a persons comment to only the agenda items. I also would like the times during which the public comment is allowed to be evaluated so that we might hear appropriate comments at times when parents are able to give more meaningful feedback. But these are just my personal thoughts.

With all that being said, thank you for being here tonight."

Motion to approve was made by Ms. Ecker, second by Mr. Nagai. Motion passed 5-0.

3.03 Recommendation to Approve Non-Certified Handbook

For the most part the changes are in red. Last year the switch was made to PTO days from sick and personal so a few of the changes were language. Another tier for paraprofessionals was added. This tier is for paras that go up and above to almost teacher duties. In addition to this he is recommending that employees be allowed to sell back vacation days if they desire.

Motion to approve was made by Mr. Nagai and second was by Mr. Lady. Motion passed 5-0.

3.04 Recommendation to Approve Administrative Handbook

Typos and items that were incorrect were updated. The same clause for selling back vacation days. Mr. Hinds asked for a motion and further discussion ensued about terms of contract with initial contracts for administrators. Mr. Nagai put a motion to table this item to the next meeting. Second was by Mr. Lady. Motion passed 3-2, with Mr. Lawrence and Ms. Ecker voting no. This items will be on the next meeting agenda.

3.05 Recommendation to Approve 2021-2022 School Improvement Plans

Brief explanations were offered by Mrs Awald and Ms. Quinn on their respective plans.

Motion to approve was made by Mr. Nagai, second by Mr. Lady. Motion passed 5-0.

3.06 Recommendation to Declare Miscellaneous Items as Junk

An inventory of the shop area revealed duplicates, items no longer needed. Items can be repurposed or used by another organization and free up some room in the shop area. Mr. Nagai made the motion and Mr. Lawrence seconded the motion. Mr. Nagai would like more specific information before items are disposed of. Motion passed 3 – 2 with Mr. Lady and Mr. Nagai voting no.

5. Curriculum

5.01 Vocational Plan – Ms. Hensley and Mrs. Awald Ms. Hensley address questions as follows: What is being done to make sure all available scholarshiops are being applied for? Scholarships are communicated through emails, Bobcat Blast, announcements, forwarding on to students, and administrators talking to students. Are we still doing convocations for the student body? Yes. What all are we doing to help our students get jobs upon graduation? Information is communicated to students about job fairs, information is passed on to students when companies call to inform about job openings. Do we have a program to help students with job interviews? All eighth grade students are enrolled in a program that works with job interviews and resume building. She as also talked with an individual to come in and work with our seniors on resume building and job interviewing. Is there any follow-up with students post-graduation? Students complete an exit form on the day the graduate. Mrs. Awald offered that the Alumni Association may be the place for follow up with graduates.

6. Reports

6.01 Superintendent Reports - Currently at 488 ADM. We have received Title II (14,000) and Title IV (11,400) allocations from the Dept. of Education. We also have \$28,000 available from ARP funds for special education. Our vocational funding is up 35,000 from last year. Collective Bargaining will resume on Wednesday. He passed to the board the job description for maintenance director. Next week we will be jumping into Neola policies to bring to the board next month and calendars for the next two years.

6.02 Principal's Reports – Mrs. Awald- open positions include math, spanish and special education. National Junior Honor Society will be posted after bargaining process. Enrollment changes, 216 in 7-12 grades, 29 withdraw and 27 new students. Field Trips - Mr. Veger's trip was approved tonight. Yearbook will be working through phone sale ads. FFA convention is coming up with 7 students attending Wednesday – Friday. They did receive donations to help cover expenses. Band had no more marching competitions at this time with the pep band will have a competition on January 15th. Lessons are taking place after school and several students were selected for honor band including Stella Awald, Chris Bottorff, Kairah Ohime, Lee Ann Stambaugh, Matthew Wringer. They will perform in the All-Region Honor Band on November 14th. Spencer Berg and Berrek Ohime will participate in the All-District Honor Band on November 21st. They will also be participating in the upcoming Talent Show. They will also be participating in music in the parks at Six Flags on May 14. High School Academic teams just kicked off their first practice tonight. Ten students have signed up. English 8 honors is going very well and English 9 honors starts up in the fall. Mr. Ash uses Darby Fitness Tests. He will look at the President Physical Fitness for next year. He encourages students to participate in team sports by introducing them in PE class and encouraging them to try it.

Ms. Quinn – K-6 skill based report cards went home on Friday, and they have had positive feedback from parents and teachers on this method of reporting. December 14 with be the Elementary Christmas Program in the high school gym. Heart Healthy month will be throught the month of February in PE classes. PTO meeting will be Wednesday. Current ADM is 235 in K-6 plus 39 in Pre-K. There is one para position open at the elementary.

7. Board Comments

Mr. Lady wants to look at the spending limits policy in the near future. The Lions club fountain is here and will be brought to the school and put in the bus barn pending the necessary hook ups being put in place on the playground. As far as Covid policy, the school is following the guidelines that have been given to schools. SCYC conducted a survey on the interest in a before school program and there was very little interest. Mr. Nagai would like to adjust our policy regarding Homeschool students participating in ECA activities. Also Mr. Nagai would like to see the public speaking policy changed.
