### 4.0 Other Business Items

4.01 First Reading of Course Description Guide - Changes have been made to the guide. Mrs. Ecker made a two page summary of the changes. Dr. Harman wants to have some additions to the beginning of the guide to explain the requirements for each diploma. Next month it will be brought back to the board for approval.

### 5.0 Curriculum

5.01 Report on School Improvement Plans - Mr. Bennett and Mr. Pletcher both presented their school improvement plans. The templates are very similar for both schools but the goals are specific to each school. The Elementary has three major goals with one in Language Arts, one in Math and one for Attendance. The Jr/Sr High School has goals in Language Arts, Math, Attendance and also Graduation.

### 6.0 Informational Agenda Items

6.01 Superintendent/Principal Reports - Dr. Harman passed out the monthly budget snapshot to the Board. The Bobcat Blast is going very well. If you know someone that would like to receive it please let us know. The Community Service day is being organized by Mr. Estok for leaf raking for members of the community. About 60 students will be participating. Mrs. Ferch and Mrs. Budka will be attending the ISBA Regional Meeting on the 25th in Plymouth. Nov. 16th there will be a dinner meeting at 5:30 CT with Michael Adamson and will also be at Christo's in Plymouth. Dr. Harman submitted the Title IV Grant. It is a new grant. The big push with this grant is STEM. Our grant was written for $\$ 51,000$. Mr. Lawrence has been selected to represent the corporation on the US 30 project. Parent/Teacher Conferences will be Wednesday evening until 6:30. Students will not be in school on Thursday, Friday or Monday. Thursday is a planned E-learning day. Information has gone out to students and parents about the E-learning day. Staff will be meeting in each building and have office hours to be available to their students. Friday and Monday is Fall Break for all staff and students. The band concert this past week was phenomenal. Dr. Harman noted that the Christmas concert is planned for the same day as our December Board Meeting. Next meeting there will be a motion to delay the Board meeting to 7:00. The Jr. High band has 24 students and the program is going very well. Dr. Harman then turned time over to Mr. Henigsmith to display what the students have been working on in their wood working classes. Many very nice projects were displayed in various stages of completion.

Mr. Pletcher thanked Mr. Henigsmith for the good work he is doing with the students in his classes. He also reported on the Manufacturing Day Field Trip in Knox. He received three thank you's for well behaved students. He said this was the first year they took seniors and he felt some of them made some very good contacts for future employment.

Mr. Bennett invited Mr. Henigsmith over to the elementary to share with the sixth grade class what they could look forward to in his classes. Mr. Bennett also reported that the first six week's attendance rate was up to $96.5 \%$ so he felt actions they have been taking to improve attendance are helping.
