## 6. Reports

6.01 Superintendent Report - Mr. Bennett gave a JESSE update and in December will bring a resolution to officially withdraw from JESSE. Plymouth has officially annouced they are withdrawing and since they were the LEA and none of the schools are willing to be the LEA, JESSE will be disbanded. The area schools have agreed to work together.

Mr. Bennett and others had their first training call with Centegix. It still looks like the goal for implementation will be shortly after the first of the year.

Raptor is up and working at the High School with a few kinks to still work out.
Mr. Bennett and Mr. Nagai met with the Project 30 advisory committee today. They will be meeting at the school on Wednesday from 5-7 with their presentation at 6:00. The PropelUS30.com website will be allowing comments.
6.02 Principal's Report - Ms. Quinn reported that Give It Back Day raised over \$1500. They were able to make food boxes for fifteen families and have enough food leftover fifteen more baskets at Christmas and also donations to the food bank.

The elementary has 30 students signed up for Enrichment with Mrs. Lucas and Mrs. Hinds. Remediations starts in January. Mrs. Hinds will be working with the lower end elementary and Mrs. Edwards with the upper end.

The Christmas program will be December 15th. Health Linc will be at the elementary on December 5th for some family fun from 4:00-6:00. The sixth grade band chose to participate with the $\mathrm{Jr} / \mathrm{Sr}$ High School program on December 5.

Ms. Duvall- again emphasized that the Band Concert will be grades 6-12 and will be at 7:00 pm .
Study tables start on Wednesday with two certified teachers. Intervention and Support group will be starting this week and will meet every other week.

The final exam schedule went out today.

## 7. Board Comments

Mr. Nagai asked about funds used for enrichment and intervention. Esser III funds are being used. Snacks for these extra times will most likely come out of food service since that account has a surplus.

Mr. Nagai also wanted to commend the superintendent and the contractor for getting the parking lot lights working. He also asked about wall packs. A quote has been received and work may be starting soon. Mr. Nagai also wanted to pubilically thank our high school principal for her committment to the school.

Mr. Lady commented that he had received in the mail a certifed letter and he wanted to make it clear that he is open to discuss teacher compensation.

Mr. Lady reached out to Dalton at North Judson to see what his financial system involves and said he would share some of these documents with Nikki.

Ms. Ecker had nothing to share.

Mr. Hinds had nothing to add.
Mr. Bennett wanted to add that he and Frank had looked at an online auction site. He felt it may be a good way to get rid of some of the items that can be declared obsolete.
